REGISTRATION OF CLUBS REGULATIONS.

PRELIMINARY.

1. These regulations may be cited as the Registration of Clubs Regulations.

INTERPRETATION.

2. In these regulations-

"Law" means the Registration of Clubs Law or any Law amending

or substituted for the same. "Town" means the towns of Nicosia, Larnaca and Scala, Limassol, Famagusta and Varosha, Ktima and Paphos, and Kyrenia.

FEES.

3. The fees to be charged and paid in pursuance of the Law shall be the fees specified in the First Appendix to these regulations and all such fees shall, unless otherwise ordered by the Registrar, be payable in stamps and shall in all cases be paid before or at the time of the doing of the matter in respect of which they are to be paid.

FORM OF REGISTER.

4. The form in the Second Appendix to these regulations shall be the form of the register to be kept by the Registrar.

5. Any person, other than any member of the Police not below the rank of Lance-Corporal, desiring to inspect the register shall make an application in writing to the Registrar.

6. The forms in the Third Appendix to these regulations shall be the forms to be used under the Law and such forms shall be used in all cases to which they are applicable and may be modified by the Registrar to meet other cases.
