

Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say:—

Rule 31. The following fees shall be paid by every person exposing for sale any perishable goods in the market of perishable goods, that is to say:—

Rule 45.—(1) The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say:—

(b) For every carcass of a young lamb or kid or part thereof	1	0
(c) For every carcass of ox, camel, cow or bullock or part thereof	1	0

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing for sale any fresh meat in the meat market, who is a monthly or yearly lessee of any shop, stall or place in the meat market under rule 45 of these rules.

Rule 53.—(1) The following fee shall be paid by the owner of or the person exposing for sale any carcass of swine or fresh pork in the pork market, that is to say, for every carcass of swine or part thereof or portion of fresh pork, one shilling.

(2) Every such fee shall be paid to the inspector.

Rule 56.—(1) The following fees shall be paid by every person exposing for sale any foodstuffs in the market of foodstuffs, that is to say:—

(a) Per stall, per day	1	0
(b) Per stand, per day	—	3
(c) Per stall, per month	20	0

(2) The fees in this rule prescribed shall be paid to the inspector.

Rule 94. There shall be paid by every occupier in the village in every year a rate not exceeding £10 to be assessed by the Commission according to the means within the area of the village of each such occupier.

Rule 95. The Commission shall on or before the 1st day of May in each year prepare a list (hereinafter in this part of these rules referred to as "the Occupiers' List"), showing the name, occupation and place of abode of every occupier in the village and the amount of the annual rate assessed on each such occupier. The Occupiers' List shall be dated and signed by the Chairman of the Commission.

Rule 99. Every occupier in the village whose name appears in the Occupiers' List shall on or before the 31st day of October pay to the Chairman of the Commission or to such other person as may be appointed Treasurer by the Commissioner, the amount of the annual rate assessed on such occupier.

THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PERIVOLIA IN THE DISTRICT OF LARNACA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Perivolía hereby make the following rules:—

1. These rules may be cited as the Village Health (Perivolía) Rules, 1953, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952 (hereinafter referred to as the "Model Rules"), published in Supplement No. 3 to the *Gazette* of the 19th November, 1952, shall—

(a) be deemed to be rules made by the Village Health Commission of Perivolia and to be incorporated herein, and

(b) apply to the village of Perivolia:

Provided that for the word "Nikos" and for the word "Nicosia" wherever they occur in the Model Rules, the word "Perivolia" and the word "Larnaca" shall be substituted respectively.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the Village of Perivolia.

THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PRASTIO MORPHOU IN THE DISTRICT OF NICOSIA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Prastio Morphou hereby make the following rules:—

1. These rules may be cited as the Village Health (Prastio Morphou) Rules, 1953, and shall come into operation on their publication in the *Gazette*.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Nikos) Rules, 1952, published in the *Gazette* of the 19th November, 1952, shall—

(a) be deemed to be rules made by the Village Health Commission of Prastio Morphou and to be incorporated herein, and

(b) apply to the village of Prastio Morphou.

(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Prastio Morphou.
