THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAW, 1950.

Order made under Section 22 (a) (i).

Authority to the Improvement Board of Panayia to contract a loan.

In exercise of the powers vested in me by section 22 (a) (i) of the Villages (Administration and Improvement) Law, 1950, I, the Acting Colonial Secretary, do hereby order as follows:—

I. The Improvement Board of Panayia (hereinafter referred to as "the Board") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of one thousand two hundred pounds ( $\pounds$ I,200) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Board to the Lender in twenty equal annual instalments (comprising sinking fund and interest);
- (b) the sum borrowed shall be utilized by the Board for the erection of nine reinforced concrete cement distribution boxes with the necessary piping in connection with the village water supply.

2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lender all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

# THE MUNICIPAL CORPORATIONS LAW. CAP. 252 AND LAWS 11 OF 1950 AND 31 OF 1951.

#### Bye-laws made by the Municipal Commission of the Municipal CORPORATION OF LIMASSOL.

Cap. 252. 11 of 1950. 31 of 1951.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Municipal Commission of the Municipal Corporation of Limassol hereby make the following bye-laws :-

1. These bye-laws may be cited as the Limassol Municipal (Amendment) Suppl. No. 3: Bye-laws, 1953, and shall be read as one with the Limassol Municipal Bye-laws, 1953 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Limassol Municipal Bye-laws, 1953.

> 2. Paragraph (g) of bye-law 76 of the principal Bye-laws is hereby amended by the deletion therefrom of the words " or similar articles are made of copper well tinned " and the substitution therefor of the following : " or similar articles made of copper are well tinned ".

> 3. Bye-law 94 of the principal Bye-laws is hereby amended by the deletion therefrom of the figure 95 and the substitution therefor of the figure 93, and the deletion of reference to paragraph (e) therefrom and the substitution of (d) therefor.

> 4. Bye-law 205 of the principal Bye-laws is hereby amended by the deletion of the word "part" in line r therefrom and the substitution of the word "past" therefor.

> 5. The First Schedule to the principal Bye-laws is hereby amended by the deletion therefrom of the inverted commas (',,') from opposite items 8, 22, 23, 39, 41, 47 and 48 and the substitution therefor of the word "piastre" opposite each such item; reference to the fees for all the remaining items being left in "paras".

> 6. These bye-laws shall be deemed to have come into effect on the 20th day of February, 1953.
