THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW. CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.

NOTIFICATION UNDER SECTION. 12 (4).

Whereas immovable property is required by the Water Commissions of Skarinou, Ayios Theodhoros and Alaminos, Larnaca District, in connection with a scheme for the supply and/or maintenance of a supply of water for the domestic purposes of the inhabitants of the said villages ;

And whereas the Commissioner of Larnaca in compliance with section 12 (2) of the Water (Domestic Purposes) Village Supplies Law, by notice Cap. 311. published under Notification No. 513 in Supplement No. 3 to the Gazette 28 of 1951. of the 19th November, 1952, and posted at a conspicuous place in the village ¹² of 1952. of Kornos gave a description and particulars of the immovable property required as aforesaid (hereinafter referred to as "the immovable property") and required any person claiming any right or interest therein to submit his claim with the necessary evidence in support thereof within the period therein set out:

And whereas the Commissioner of Larnaca at the expiration of the period set out in the aforesaid notice forwarded to the Governor a plan of the immovable property together with particulars as regards its owners, description and estimated value, and together with four objections made against the proposed acquisition;

And whereas I have approved the plan submitted and I consider it expedient, having regard to all the circumstances, that the Water Commissions of Skarinou, Ayios Theodhoros and Alaminos should be permitted to acquire the immovable property :

Now, therefore, in exercise of the powers vested in me by section 12 (4) Cap. 311. of the Water (Domestic Purposes) Village Supplies Law, I, the Governor, 28 of 1951. 12 of 1952. do hereby sanction the acquisition of the immovable property.

THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following rules made by the Committee of the Irrigation Association of Akapnou (" Livadhia " locality), in the District of Limassol, are published in the Gazette.

IRRIGATION ASSOCIATION OF AKAPNOU (" LIVADHIA LOCALITY ").

Rules.

1. These rules may be cited as the Irrigation Association of Akapnou ("Livadhia" Locality) Rules, 1953.

2. In these rules, unless the context otherwise requires-

Commissioner" means the Commissioner of the District of Limassol;

"Committee" means the Committee of the Irrigation Association; "Irrigation Association" means the Irrigation Association of Akapnou ("Livadhia"

"Law" means the Irrigation (Private Water) Association Law, 1949; "Law" means the list of the names and residences of the proprietors and of the extent "List" means the list of the names and residences of the proprietors and of the extent provisions of section 11 of the Law;

Water " means the water commonly known as " Livadhia " Water ;

Works " means the irrigation works of the Irrigation Association.
