REGULATIONS MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Bombardment Cap. 222. Range Areas Law, I, the Governor, do hereby make the following 23 of 1951. regulations :----

1. These regulations may be cited as the Bombardment Range Areas Gazettes : (Amendment) Regulations, 1953, and shall be read as one with the Suppl. No. 3: Bombardment Range Areas Regulations, 1949 to 1952 (hereinafter referred 18,1949 to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Bombardment Range Areas Regulations, 1949 to 1953.

2. The principal Regulations are hereby amended by the insertion therein, immediately after regulation 23 (as set out in the Bombardment Range Areas (Amendment) Regulations, 1952) of the following regulations :--

"24. In this part of these regulations, the "DHEKELIA Bombardment Range Area" means the area declared as such under section 2 of the Law by notice to be published in the Gazette or by any other notice amending or substituted for the same.

25. The danger signals to be hoisted in respect of DHEKELIA Bombardment Range Area shall be as follows :---

(a) By Day.

(i) By a red flag hoisted on the high ground to the NORTH of the 600 yards firing point.

(ii) By a red flag hoisted to the NORTH-WEST of the butts.

- (iii) By a red flag hoisted at the Northern end of the WEST boundary of the range.
- (iv) By a red flag hoisted on the high ground on the SOUTH-WEST boundary of the range and NORTH of the LARNACA road.
- (v) By a red flag hoisted at the road junction half way between the fourth and fifth milestones-LARNACA-XYLOTYMBOU road.

By red lamps hoisted on flag poles situated as in (a) (i), (ii), (iii), (iv) and (v) above."
