ORDER AND DIRECTIONS UNDER SECTIONS 4 AND 57.

Cap. 142. In exercise of the powers vested in me by sections 4 and 57 of the Villages (Administration and Improvement) Law, 1950 (hereinafter referred to as "the 1950 Law"), I, the Governor, do by this Order declare that the village of Kophinou in the district of Larnaca (hereinafter referred to as "the village"), to which the provisions of the Public Health (Villages) Law (hereinafter referred to as "the Public Health Law") at present apply, be an improvement area for the purposes of the 1950 Law, and I further do hereby direct that—

- (a) the Village Health Commission, constituted under the provisions of the Public Health Law in respect of the village, shall be deemed to be a Board established under and for the purposes of the 1950 Law in respect of the village and shall continue to function until a new Board is established in its place as in the 1950 Law provided ;
- (b) all Rules made under the provisions of the Public Health Law, in respect of the village, shall be deemed to be bye-laws made under the provisions of the 1950 Law in respect of the village, in so far as they are not inconsistent with the provisions of the last mentioned Law, and such Rules shall remain in force until revoked or replaced by bye-laws made under the provisions of the 1950 Law.

In exercise of the powers vested in me by section 3 of the Bombardment Range Areas Law, I, the Governor, do hereby make the following regulations :—

1. These regulations may be cited as the Bombardment Range Areas (Amendment) Regulations (No. 2), 1953, and shall be read as one with the Bombardment Range Areas Regulations, 1949 to 1953 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Bombardment Range Areas Regulations, 1949 to (No. 2) 1953.

2. The principal Regulations are hereby amended by the insertion therein, immediately after regulation 25 (as set out in the Bombardment Range Areas (Amendment) Regulations, 1953) of the following regulations :—

" *The Akrotiri Bombardment Range Areas.*

26. In this part of these Regulations the 'Akrotiri Bombardment Area' means the area declared as such under section 2 of the Law by

notice to be published in the *Gazette* or by any other notice amending or substituted for the same.

27.—(a) The danger signals to be hoisted in respect of Akrotiri Bombardment Range Area shall be red flags at intervals of 200 yards on the circumference of the Range.

(b) The area shall not be used by night.”

THE BOMBARDMENT RANGE AREAS LAW.
CAP. 222 AND LAW 23 OF 1951.

NOTICE UNDER SECTION 2.

In exercise of the powers vested in me by section 2 of the Bombardment Range Areas Law, I, the Governor, do hereby declare the area set out in the Schedule hereto to be a Bombardment Range Area for the purposes of the aforesaid Law, for a period of twelve months from the date of this notice.

SCHEDULE.

The boundary forms part of a circle and encloses part of AKROTIRI Main State Forest and part of the Merra of AKROTIRI in the village of AKROTIRI in the District of LIMASSOL. The centre of the said circle is at a point on the seashore, the co-ordinates of which on the Survey of CYPRUS grid are $X-118440$, $Y-140750$ feet. The radius of the said circle is 3,000 feet. All which said boundary is represented on the map 1:50,000 CYPRUS sheet 6 EPISKOPI, by a part of the circle, centre at the point, map reference 639071 and radius 1,000 yards, commencing at the point, map reference 635079, on the seashore and proceeding in a clockwise direction to the point, map reference 642063, on the seashore.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 45 in Supplement No. 3 to the *Gazette* of the 7th February, 1951, the Governor declared the establishment of a military cantonment within the villages of Ormidhia, Xylotymbou and Pyla, in the District of Larnaca, the cost whereof is to be borne by Her Majesty's Military Authorities, to be an undertaking of public utility;

And whereas the Commissioner of Larnaca by notice published under No. 110 in Supplement No. 3 to the *Gazette* of the 4th March, 1953, gave particulars of an easement required to be acquired in connection with the
