No. 277. THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAW, 1950.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF KALAVASOS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Law, 1950, the Improvement Board of Kalavastos hereby make the following bye-laws:—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Kalavastos (Amendment) Bye-laws, 1953, and shall be read as one with the Villages (Administration and Improvement) Kalavastos Bye-laws, 1951 and 1952 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Kalavastos Bye-laws, 1951 to 1953.

2. Bye-law 155 (2) (d) of the principal Bye-laws is hereby amended by the deletion therefrom of the figure 1s. and the substitution therefor of the figure 5s.

3. Bye-law 155 (2) of the principal Bye-laws is hereby amended by the insertion therein immediately after (d) of the following proviso:—

"Provided that, in lieu of the above fees, an annual fee not exceeding ten pounds may be paid by persons who come to the village selling their produce in vans, lorries, motor cars, carts or other similar vehicles."
