No. 27. THE TRADING WITH THE ENEMY LAW. CAP. 174.

ORDER MADE BY THE GOVERNOR UNDER SECTIONS 3 (2) AND 14.

A. B. WRIGHT, Governor.

In exercise of the powers vested in me by sections 3 (2) and 14 of the Trading with the Enemy Law (hereinafter referred to as "the Law"), I, the Governor, do hereby order as follows:—

1. This Order may be cited as the Trading with the Enemy (Enemy Territory Cessation) (Germany) Order, 1953.

2. Germany shall for the purposes of this Order and for the purposes of any Order made thereunder cease to be treated as if it were enemy territory.

3. For the purposes of this Order "Germany" means territory comprised in the German State on the 1st March, 1938.

4. This Order shall be deemed to have come into operation on the 6th October, 1952.

3. In this Order "Japan " means all territory which was under Japanese Sovereignty on the 28th September, 1944.

4. This Order shall be deemed to have come into operation on the 20th November, 1952.

THE LAND ACQUISITION LAW. CAP. 233.

NOTICE UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to me that it is desirable for military purposes to establish a military cantonment within the villages of Paramali, Sotira, Episkopi, and Evdhimou in the District of Limassol, the cost whereof is to be borne by Her Majesty's Military Authorities (hereinafter referred to as "the Cantonment"):

Now, therefore, I, the Governor, in exercise of the powers vested in me by sections 2, 3 and 5 of the Land Acquisition Law, Cap. 233, do hereby declare the establishment of the cantonment to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust the supervision and effectuation of the said undertaking to Mr. Percy George Crosbye Farrell, the Assistant Director of Hirings and Disposals (Fixed Assets), H.Q. Cyprus District, or in his absence to the person acting for the time being as Assistant Director of Hirings and Disposals (Fixed Assets), H.Q. Cyprus District.
