THE LAND ACQUISITION LAW.  
CAP. 233 AND LAW 26 OF 1952.

## NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 272 in Supplement No. 3 to *Gazette* No. 3692 of the 28th May, 1953, notice is hereby given that the following land is required by the Governor for the undertaking of public utility mentioned therein :

All that area of privately owned land situated in Taht-el-Kale Quarter of Nicosia town and in Palouriotissa village comprising 8 donums, 2 evleks and 2,960 sq. feet or thereabouts, including part of plots Nos. 34, 40, 41, 42, 43, 44, 45, 52, 46, 47, 48, 49, 50 and 51 of Block A, Taht-el-Kale Quarter of Nicosia town (Government Survey Plan No. XXI.47.I.III); part of plots Nos. 127, 128, 129 of Block A, Palouriotissa village (Government Survey Plan No. XXI.47.I.III), and part of plots Nos. 130, 131, 156, 111, 112, 53, 110, the whole of plot No. 240, part of plots Nos. 255, 256, the whole of plots Nos. 254, 257, part of plots Nos. 91, 103, the whole of plots Nos. 239, 235, 104, 234, 232, 233, 231, 159 and part of plot No. 262 of Block A, Palouriotissa village (Government Survey Plan No. XXI.47.I.III) more particularly defined as the areas coloured red on the Government Survey Plan Serial No. 1589, deposited with the Commissioner, Nicosia-Kyrenia.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Nicosia.

THE AGRICULTURAL PRODUCE EXPORT REGULATIONS, 1953.

ORDER UNDER PARAGRAPHS 2 AND 4 OF PART V OF THE FOURTH APPENDIX.

In exercise of the powers vested in me by paragraphs 2 and 4 of Part V of the Fourth Appendix to the Agricultural Produce Export Regulations, 1953, I, the Director of Agriculture, do hereby order that, until further notification, potatoes, graded as "Selected" or "New Potatoes" and intended for export to the United Kingdom shall be separated into sizes "Large", "Medium" or "Small" as specified in the aforesaid Regulations and the containers shall be marked accordingly in letters 1" height.
