THE AGRICULTURAL PRODUCE (EXPORT) LAW. CAP. 39.

ORDER IN COUNCIL No. 2632

MADE UNDER SECTION 3.

J. Fletcher-Cooke, Acting Governor.

In exercise of the powers vested in me by section 3 of the Agricultural Produce (Export) Law (hereinafter referred to as "the Law"), I, the Acting Cap. 39. Governor, with the advice of the Executive Council, do, by this Order, order and declare as follows :-

- 1. This Order may be cited as the Agricultural Produce (Export) (Declaration) Order, 1953.
- 2. The provisions of the Law shall apply to the export of the agricultural produce specified in the first column of the First Schedule hereto to the countries specified in the second column of the said Schedule.
- 3. The Orders-in-Council set out in the Second Schedule hereto are hereby cancelled without prejudice to anything done or left undone thereunder.

FIRST SCHEDULE.

Agricultural Produce	Country
1. Agricultural Produce Class I. Citrus Fruit and Pomegranates	All countries.
Fresh fruit (Apples, Apricots, Cherries, Figs, Grapes, Kaishas, Melons, Peaches, Pears, Plums, Tomatoes) 3. Agricultural Produce Class III.	All countries.
Nuts (Almonds, Hazelnuts, Walnuts), Dried fruit (Figs (dried) Apricots and Kaishas (dried) and Raisins) 4. Agricultural Produce Class IV.	All countries.
Onions, Onion Sets, Potatoes, Sage leaves and Yellow-leaf tobacco	All countries.

THE FOREST LAW. CAP. 93.

ORDER IN COUNCIL No. 2633

MADE UNDER SECTION 3.

J. FLETCHER-COOKE, Acting Governor.

In exercise of the powers vested in me by section 3 of the Forest Law, I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Main State Forest (Halevga and Koronia Group) (Amendment) Order, 1953, and shall be read as one with the Main State Forest (Halevga and Koronia Group) Order, 1941 (No. 1992) as amended by the Main State Forests Amendment (No. 1) Order, 1942 (No. 2045) and the Main State Forests (Halevga and Koronia Group) (Amendment) Order, 1949 (No. 2394) and the principal Order and this Order may together be cited as the Main State Forest (Halevga and Koronia Group) Orders, 1941 to 1953.

2. The area of land and forest specified in the Schedule hereto is hereby declared to be no longer Main State Forest for the purposes of the Forest Law and Part I of the Schedule to the principal Order shall be read subject to the Schedule hereto.

SCHEDULE.

All that forest and area of land defined in Part I of the Schedule to the principal Order and recorded as the "Ayios Khariton" Forest.
