NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 45 in Supplement No. 3 to the *Gazette* of 7th February, 1951, notice, is hereby given that the following easement is required for the undertaking of public utility mentioned therein, that is to say, the establishment of a Military Cantonment in the villages of Pyla, Xylotymbou and Ormidhia in the District of Larnaca :—

The laying and maintaining of a pipe-line in, over or under the following lands, situated in the villages of Pergamos and Pyla in the District of Larnaca :—

(a) *In the village of Pergamos.*

Plots Nos. 13, 304, 235, 221 and 215 of the Government Survey Plan No. XXXII.51, plots Nos. 26, 27, 28, 29/2, 30, 34, 35, 97.40, 97.39, 36, 37, 50, 51, 49, 48, 47, 82, 81/2, 81/3, 83, 95 and 84 of the Government Survey Plan No. XXXII.59.

(b) *In the village of Pyla.*
