**THE LAND ACQUISITION LAW.**  
**CAP. 233 AND LAW 26 OF 1952.**

**NOTICE UNDER SECTION 6.**

With reference to the notification published under No. 299 in Supplement No. 3 to the *Gazette* No. 3699 of the 18th June, 1953, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein :

All those areas of privately owned land, with everything standing on them situated at Nicosia, Ayios Andreas Quarter, including part of plot No. 16 (disused Roman Catholic Cemetery) and part of plots Nos. 17, 18 and 18/1, Block No. 26, Ayios Andreas Quarter, Nicosia Town, of the Government Survey Plan No. XXI.46.4.II comprising 1 donum, 1 evlek and 3,320 sq. feet or thereabouts, more particularly defined as the area coloured yellow on the plan marked " Pedieos Bridge Approach Roads " dated 29th July, 1953, copy of which has been deposited with the Commissioner, Nicosia and Kyrenia.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Nicosia.
