CAP. 233 AND LAW 26 OF 1952.****NOTICE UNDER SECTION 6.**

With reference to the Notification published under No. 371 in Supplement No. 3 to the *Gazette* No. 3517 of the 13th September, 1950, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein :
