In exercise of the powers vested in me by section 6 (2) of the Elementary Education Law, I, the Acting Governor, do hereby order as follows:—

1. This Order may be cited as the Elementary Education (Prescription of Groups) (Amendment) Order, 1953, and shall be read as one with the Elementary Education (Prescription of Groups) Orders, 1951 and 1952 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Elementary Education (Prescription of Groups) Orders, 1951 to 1953.

2. The First Schedule to the principal Order is hereby amended by the deletion therefrom of the word and comma "Eylenja", occurring in column 2 thereof, in respect of the Moslem religious community.

3. The Second Schedule to the principal Order is hereby amended as follows:—

(a) by the deletion therefrom of the words "Petra-Elea", occurring in column 2 thereof, under the heading "Nicosia District", of the words "Livadhia-Kellia", occurring in column 2 thereof, under the heading "Larnaca District", of the words "Kividhes, Pano-Kato" occurring in column 2 thereof, under the heading "Limassol District", of the words "Ayios Dhimitrianos-Psathi" occurring in column 2 thereof, under the heading "Paphos District" in respect of the Greek-Orthodox religious community, and by the insertion in column 2 thereof, in the proper alphabetical order of the words "Polemi-Psathi" under the heading "Paphos District", in respect of the Greek-Orthodox religious community;

(b) by the deletion therefrom of the words "Peristerona-Orounda", "Petra-Ayios Yeoryios Lefkas", "Skyloura-Ayios Vassilios-Ayia Marina Skylouras-Ayios Ermolaos" occurring in column 2 thereof, under the heading "Nicosia District", of the words "Evretou-Trimithousa Khrysokhou-Loukrounou" occurring in column 2 thereof, under the heading "Paphos District" in respect of the Moslem religious community and by the insertion, in column 2 thereof, in the proper alphabetical order, of the words "Skyloura-Ayia Marina Skyloura-Ayios Ermolaos" under the heading "Nicosia District", in respect of the Moslem religious community.
