Order made under Section 22 (a) (i).

Authority to the Improvement Board of Prodhromos to contract a loan.

In exercise of the powers vested in me by section 22(a) (i) of the Villages (Administration and Improvement) Law, 1950, I, the Acting Colonial Secretary, do hereby order as follows:—

1. The Improvement Board of Prodhromos (hereinafter referred to as "the Board") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") a sum not exceeding four thousand six hundred pounds (£4,600) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions that is to say:—

- (a) the sum borrowed shall be repayable by the Board to the Lender in ten equal annual instalments (comprising sinking fund and interest);
- (b) the sum borrowed shall be utilized by the Board for the improvement and widening of streets, and the provision of car parks and fair grounds.

2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lender all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

BYE-LAWS MADE BY THE WATER COMMISSION OF KATO ARKHIMANDRITA VILLAGE (PAPHOS DISTRICT) UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Kato Arkhimandrita village, in the District of

Bye-laws, 1953. 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the *Gazette* of 1st November, 1950, shall---

(a) be deemed to be bye-laws made by the Water Commission of Kato Arkhimandrita and to be incorporated herein, and

(b) apply to the village of Kato Arkhimandrita.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.

(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Kato Arkhimandrita.

BYE-LAWS TO BE SUBSTITUTED.

Bye-law 2.—In these bye-laws, unless the context otherwise requires— "Commissioner" means the Commissioner of the District of Paphos and includes an

Assistant Commissioner of that District; "Law" means the Water (Domestic Purposes) Village Supplies Law and any law amending or substituted for the same;

"Village" means the village of Kato Arkhimandrita; "Water" means the water of the water supply;

"Water Commission " means the Water Commission of Kato Arkhimandrita village;
