## NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 30 in Supplement No. 3 to the *Gazette* No. 3669 of the 28th January, 1953, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein :—

(i) *Land in Paramali village.*

All that privately-owned land, situated in the village of Paramali, in the District of Limassol, at the localities "Kapsalin" and "Kholetrin" being plot No. 104 of the Government Survey Plan No. LVIII.1 comprising 265 donums or thereabouts and belonging to George N. Houry of Limassol.

(ii) *Land in Sotira village.*
