No. 506. THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951 AND 20 OF 1953.

Bye-laws made by the Council of the Municipal Corporation of Nicosia.

In exercise of the powers vested in them by the Municipal Corporations Cap. 252. Law, and otherwise, the Council of the Municipal Corporation of Nicosia 11 of 1950 hereby make the following bye-laws:—

1. These bye-laws may be cited as the Nicosia Municipal (Amendment) Bye-laws, 1953, and shall be read as one with the Nicosia Municipal Bye-laws, 1938 to 1952 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Nicosia Municipal Bye-laws, 1938 to 1953.

2. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 124 of the following bye-law:-

"124A.—(1) Except with the consent of the Council, previously obtained, no person shall within the municipal limits of Nicosia,-

- (a) cook or engage in cooking or cause to be cooked any food in any
- (b) cook or engage in cooking or cause to be cooked any food in any place of public resort within a distance of 100 feet from any street except under the licence of the Council subject to such terms and conditions as the Council may see fit to impose:

Provided that nothing in this bye-law shall apply to the cooking of any food in any enclosed kitchen in any such place which complies with the provisions of these bye-laws.

(2) Nothing in this bye-law shall affect any right of any person against any other person for nuisance, annoyance or inconvenience which may be caused by the cooking of any food in any place whatsoever."

The above bye-laws have been approved by His Excellency the Governor. (M.P. 985/49/2.)
