2. Regulation 2 of the principal Regulations is hereby amended by the

addition thereto of the following proviso:

"Provided that the Director of Agriculture may, for special reasons, in his discretion and subject to such conditions as he may deem fit to impose, permit the export for industrial purposes of any produce enumerated in the Schedule hereto which contains foreign, superfluous or inferior substance, matter or thing in excess of the percentage prescribed in the said Schedule".
