## THE PORT WORKERS (REGULATION OF EMPLOYMENT) LAW, 1952.

REGULATIONS MADE UNDER SECTION 5.

## A. B. WRIGHT,

Governor.

In exercise of the powers vested in me by section 5 of the Port Workers (Regulation of Employment) Law, 1952, I, the Governor, with the advice of 35 of 1952. the Executive Council, do hereby make the following Regulations:-

- 1. These Regulations may be cited as the Port Workers (Regulation of Employment) (Amendment) Regulations, 1953, and shall be read together with the Port Workers (Regulation of Employment) Regulations, 1952 (set out in the Schedule to the Port Workers (Regulation of Employment) Law, 1952, and hereinafter referred to as "the principal Regulations").
- 2. Regulation 2 of the principal Regulations is hereby amended by the deletion of the semi colon at the end of the definition of "manager" and the substitution of the following:-

"and includes an assistant manager of such employment exchange;".

3. Regulation 5 of the principal Regulations is hereby amended by the substitution of the following paragraph for paragraph (1) thereof:—

"(1) Subject to paragraphs (2) and (3) of this Regulation it shall not be lawful for any person to work as port worker in any port where these Regulations apply unless he is registered in accordance with paragraph (1) of Regulation 4 of these Regulations and is allocated to an employer by the manager.".

4. Regulation 8 of the principal Regulations is hereby amended by the substitution of the following paragraphs for paragraph (3) thereof:—

"(3) If the wages are not fixed and the working conditions are not determined as provided in paragraph (2) of this Regulation the Chairman of the Board shall refer the question for determination to a tribunal consisting of a Chairman and two members appointed by the Governor, one member representing employers' interests and the other member workers' interests. Any decision of such tribunal shall be final and binding on all parties.

(4) For the purposes of this Regulation "employer" means any

employer of workers.".

Notice under Section 11.

In exercise of the powers vested in me by section 11 of the Antiquities Law, I, the Governor, do hereby order as follows:—

From and after the date of the publication of this notice in the Gazette no building shall be erected, reconstructed or repaired and no tree shall be felled within the areas adjacent to an ancient monument to wit the site and remains of the Temple of Venus in the village of Kouklia (Palea Paphos), comprising the plots specified in the Schedule hereto save in accordance with the terms of a permit in writing from the Commissioner previously obtained.
