NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 272 in Supplement No. 3 to the *Gazette* of the 28th May, 1953, I, the Governor, declared the laying out and construction of a new main road connecting the Kythrea Road and the Athina Boulevard north of the Altun (Caraffa) Bastion in the village of Palouriotissa and the town of Nicosia and the acquisition of certain lands mentioned in the aforesaid Notification, to be an undertaking of public utility ;

And whereas the Commissioner, Nicosia and Kyrenia, by notice published under No. 288 in Supplement No. 3 to the *Gazette* of the 11th June, 1953, gave particulars of the properties required in connection with the aforesaid undertaking ;

And whereas the Commissioner forwarded to the Governor the required recommendations, plan and particulars, together with the objections made ;

And whereas, I, the Governor, have approved the plan and particulars submitted, subject to slight amendments, by the reduction of the area to be acquired from plots Nos. 34, 40, 46 and 52 of Block A, Taht-el-Kale Quarter, Nicosia Town (Government Survey Plan No. XXI.47.I.III) and have considered it expedient, having regard to all the circumstances of the case, that the properties in question less the small areas of the said plots excluded by the amendment of the plan and particulars, be acquired :

Now, therefore, in exercise of the powers vested in me by section 7 of the Land Acquisition Law, I, the Governor, do hereby sanction the acquisition under the provisions of the said Law of the properties particulars whereof are specifically set out in the Schedule hereto.

SCHEDULE.

All that area of privately-owned immovable property situated in Taht-el-Kale Quarter of Nicosia town and in Palouriotissa village comprising 8 donums, 2 evleks and 2,625 square feet or thereabouts, including part of plots Nos. 34, 40, 41, 42, 43, 44, 45, 52, 46, 47, 48, 49, 50 and 51 of Block A, Taht-el-Kale Quarter of Nicosia town (Government Survey Plan No. XXI.47.I.III) ; part of plots Nos. 127, 128, 129 of Block A, Palouriotissa village (Government Survey Plan No. XXI.47.I.III), and part of plots Nos. 130, 131, 156, 111, 112, 53, 110, the whole of plot No. 240, part of plots Nos. 255, 256, the whole of plots Nos. 254, 257, part of plots Nos. 91, 103, the whole of plots Nos. 239, 235, 104, 234, 232, 233, 231, 159 and part of plot No. 262 of Block A, Palouriotissa village (Government Survey Plan No. XXI.47.I.III) more particularly defined as the areas coloured red on the Government Survey Plan Serial No. 1598.
