In exercise of the powers vested in me by the Emergency Laws (Miscellaneous Provisions) (Colonies, etc.) Order in Council, 1953, and of every other power thereunto enabling, I, the Governor, do hereby make the following Order :—

1. This Order may be cited as the Emergency Laws (Miscellaneous Provisions) (Cyprus) Order, 1953.

2. The Defence Regulations set out in the Schedule to the Emergency Laws (Transitional Provisions) (Cyprus) Order, 1946, shall continue in force until the 10th day of December, 1954, and the said Order shall have effect as if, for the reference to the 10th day of December, 1953, in clause 3 thereof (as inserted by the Emergency Laws (Miscellaneous Provisions) (Cyprus) Order, 1952), there were substituted a reference to the 10th day of December, 1954.

(CYPRUS) ORDER, 1946.****ORDER MADE UNDER DEFENCE REGULATION 64.**

In exercise of the powers vested in me by Defence Regulation 64, as set out in the Schedule to the Emergency Laws (Transitional Provisions) (Cyprus) Order, 1946, which continues in force under the Emergency Laws (Miscellaneous Provisions) (Cyprus) Order, 1953, I, the Governor, do hereby authorize the use from time to time of the six areas of land specified in the Schedule hereto (hereinafter referred to as "the land"), for military and airforce purposes during the period commencing on 11th December, 1953, and ending on 31st December, 1953, and any person using the Land in pursuance of this Order may, in relation to the Land, do all or any of the following acts, that is to say :—

- (a) drop parachutists on to the Land from aircraft ;
- (b) drop any form of equipment or vehicle on to the Land from aircraft ;
- (c) enter on the Land for the purpose of making the arrangements for the acts mentioned in (a) and (b) above and to erect warning signals as hereinafter provided ;
- (d) enter on the Land for the purpose of recovering equipment or vehicles dropped :

Provided that on each occasion before the Land is used for the aforesaid acts, the following conditions shall be fulfilled by the user of the Land, that is to say :—

- (i) reasonable notice shall be given to the Mukhtars of—

- (a) Nikitas village ; and
- (b) Kato Zodhia, Ayios Vasilios, Mammari, Beuyük Kaimakli, Palekythro, Tymbou, Prastio, Gaidhouras, Kalopsidha, Linnia, Aloa, Lefkoniko, Gyposos and Milea villages,

of the intention to use the Land ;

- (ii) not less than half an hour before the intended use is due to begin, adequate warning signals shall be placed round the perimeter of the Land ;
- (iii) during the time that the warning signals are in position, a Safety Officer shall be in charge of all operations, authorized to take all the necessary steps for clearing the Land before it is used and for keeping it clear during use.

2. No person (including any person enjoying any right over the Land whether by virtue of an interest in the Land or otherwise) other than a member of H.M. Forces shall enter or be on the Land so long as the warning signals are in position.

3. From and after the date of the publication of this Order in the *Gazette*, no person (including any person enjoying any right in or over the Land whether by virtue of an interest in the Land or otherwise) shall erect any building on the Land or plant any tree on the Land or perform any act on the Land, save with a written permit from the Commissioner of the District in which the Land is situated.

4. The use of the Land by H.M. Forces shall be subject to the condition that there shall be paid by Her Majesty's Government to the person for the time being entitled to occupy the Land, compensation for the use and possession thereof and for any damage thereto which, in default of agreement, shall be assessed under the provisions of the Compensation (Defence) Law or in accordance with the provisions relating to compensation in respect of taking possession of Land as therein contained.

5. Any person who contravenes or fails to comply with any of the provisions of this Order is liable, under Defence Regulation 94 as set out in the Schedule to the aforesaid Emergency Laws (Transitional Provisions) (Cyprus) Order, 1946, to imprisonment for a term not exceeding three years or to a fine not exceeding one hundred pounds or to both such imprisonment and fine.

SCHEDULE.

Area " A "

The boundary encloses all or part of the localities " Kakourtas " and " Ayios Andhronikos " in the village of Nikitas in the District of Nicosia and all or part of the localities " Xeropotamos ", " Dhromos tis Paphou ", " Dhromos tou Nikita ", " Koukouzes ", " Ammous ", " Potami ", " Kanakoudhes ", " Dhromos tou Kokkinokremou ", " Dhromos tis Mandras ", " Kamyli ", " Laxia tou Piskali ", " Asprokhoma " and " Paleomandres " in the village of Kato Zodhia in the District of Nicosia.

All which said boundary is represented on the Map 1 : 50,000 Cyprus Sheet 4 Morphou, by a line joining the points in succession whose map references are 669684, 677688, 704690 and 704663.

Area " B "

The boundary encloses all or part of the localities " Arries ", " Troulia " and " Mazeres " in the village of Ayios Vasilios in the District of Nicosia and all or part of the localities " Strongylovounaron ", " Kolimbes ", " Paleo Djimistron " and " Spitoudhia " in the village of Mammari in the District of Nicosia.

All which said boundary is represented on the Map 1 : 50,000 Cyprus Sheet 8 Nicosia, by a line joining the points in succession whose map references are 886734, 907733, 906723 and 885724.

Area " C ".

The boundary encloses all or part of the localities " Toumba tou Pitsiliou ", " Almyros " and " Laxia tou Arphala " in the village of Beuyuk Kaimakli in the District of Nicosia and all or part of the localities " Rotsos tou Mavrou ", " Deyirmen Tashi ", " Yousouf Arab ", " Spillious ", " Veli Tarlasi ", " Landes Makries ", " Arilik ", " Paleokklisha ", " Khoraphin tou Kountourou " and " Dikili Tash " in the village of Palekythro in the District of Nicosia and all or part of the localities " Glypha " and " Rothessa " in the village of Tymbou in the District of Nicosia.

All which said boundary is represented on the Map 1 : 50,000 Cyprus Sheet 12 Kythrea, by a line joining the points in succession whose map references are 136694, 164689, 159669 and 132671.

Area " D ".

The boundary encloses part of the locality " Prastion Pasturage " in the village of Prastio in the District of Famagusta, and all or part of the localities " Arkaji tou Rousha ", " Mandres tou Hj Anastassi ", " Bey Tarlasi " and " Sterna " in the village of Gaidhouras in the District of Famagusta and all or part of the localities " Arkaja ", " Palio Mandres ", " Pano Laparkia ", " Skali tou Hassani ", " Exopotamos ", " Exoyofiri ", " Lapatkia ", " Mazerka ", " Kashanos Arkaja ", " Yofirka ", " Limnes ", " Limnes tou Kambi ", " Alapatkia ", " Kato Alapatkia ", " Kambi ", " Pastardou ", " Kazaveradhes ", " Mazeroudhia ", " Mandres ", " Platses ", " Chatali ", " Sklavos ", " Vounaroudhi ", " Campi Pastarda ", " Kounniyes ", " Conia ", " Vokolomandra " and " Vasiliji " in the village of Kalopsidha in the District of Famagusta.

All which said boundary is represented on the Map 1 : 50,000 Cyprus Sheet 12 Kythrea, by a line joining the points in succession whose map references are 424660, 464643, 450600 and 413629.

Area " E ".

The boundary encloses all or part of the localities " Kamini Sarandanas ", " Trachonas tis Alodas ", " Limnia Kiraji ", " Petravlako ", " Mazeradhes ", " Kamini ", " Dhromos Mazeri ", " Sohorafo ", " Maravioti ", " Pervoli ", " Moroussa ", " Exalona ", " Asproya " and " Trakhona " in the village of Limnia in the District of Famagusta and part of the locality " Kochines Kamini " in the village of Aloa in the District of Famagusta.

All which said boundary is represented on the Maps 1 : 50,000 Cyprus Sheet 12 Kythrea and 15 Famagusta by a line joining the points in succession whose map references are 473740, 492732, 487711 and 467718.

Area " F ".

The boundary encloses all or part of the localities " Kochinoyes ", " Exo-Trakhonas ", " Vathia Laxia ", " Plakotaes ", " Athasha ", " Yisufies " and " Kambia " in the village of Lefkoniko in the District of Famagusta and all or part of the localities " Strongylovounos ", " Yofiras " and " Varkes Katsoura ", in the village of Gypsos in the District of Famagusta and all or part of the localities " Mavroyanni ", " Ayios Elias ", " Kallikaes Vounos ", " Niolita ", " Toumbes Saghouri ", " Toumba Yofirkou " and " Koumallos " in the village of Milea in the District of Famagusta.

All which said boundary is represented on the Maps 1 : 50,000 Cyprus Sheet 11 Lefkoniko and 12 Kythrea, by a line joining the points in succession whose map references are 391788, 414788, 413765 and 389774.
