THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF STROVOLOS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Strovolos hereby make the following bye-laws:-

1. These bye-laws may be cited as the Villages (Administration and Gazettes: Improvement) Strovolos (Amendment) Bye-laws, 1953, and shall be read Suppl. No. 3: as one with the Villages (Administration and Improvement) Strovolos Byelaws, 1951 and 1952 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Strovolos Bye-laws, 1951 to 1953.

- 2. The principal Bye-laws are hereby amended by the insertion therein, immediately after bye-law 166, of the following bye-law:—
 - "1661. Any person driving or having the charge or control of a motor car, or riding a bicycle, or driving, pushing or having the charge or control of an animal-drawn vehicle, in any street shall-
 - (a) comply with all traffic signs erected, exhibited, placed or painted in or near any street by the Board;
 - (b) obey all notices or signs which may be erected, exhibited, placed or painted by the Board in or near any street or so as to be visible from any street, for the regulation of traffic;
 - (c) when entering into a main street, slow down or halt and give way to traffic in the main street."
