THE DISTRIBUTION OF GERMAN ENEMY PROPERTY ORDER, 1953.

ORDER MADE UNDER CLAUSE 13.

In exercise of the powers vested in me by clause 13 of the Distribution of German Enemy Property Order, 1953, I, the Governor, do hereby order as follows :-

1. This Order may be cited as the German Enemy Property (Administrator of German Enemy Property) (Vesting) Order, 1953.

2. There shall vest in the Administrator of German Enemy Property appointed pursuant to the terms of the said Order all rights or interests in the estate of a deceased person, which are German enemy property as defined by the Distribution of German Enemy Property Law, 1953, where no probate has nor letters of administration have been granted or resealed in the Colony at the date of this Order or where a limited grant only (not being a grant to an attorney administrator or attorney administrators) has been made or where confirmation has not been granted at that date, including the right to receive, recover and be paid any monies payable presently or at any future time in respect of any such rights and interests and to receive and take possession of any property transferable by virtue thereof: Provided nevertheless that if the vesting to be effected by this Order would cause a forfeiture or determination of any such right or interest as aforesaid then in any such case this Order shall not have the effect of vesting the same in the said Administrator and provided also that there shall be excepted from the vesting to be effected by this Order any estate or interest in land.

3. The said Administrator shall have the following rights and powers with regard to the said property, rights and interests, namely :-

- (a) to sell or otherwise dispose of and to transfer any such property, rights or interests as aforesaid,
- (b) to give a receipt or other effective discharge for any monies or other property payable or transferable to the said Administrator by virtue of this Order,

- (c) to recover and sue for any such monies or property as aforesaid and to enforce any rights or interests vested in the said Administrator as aforesaid,
- (d) to compromise any matter and to accept any composition or any payment or transfer on account,
- (e) generally to do any act or thing that may be necessary or proper reducing to possession recovering or protecting any such for property, rights and interests as aforesaid, or for enforcing or making effective and complete the vesting effected by this Order and carrying out the powers, rights and duties of the said Administrator in connection with the same.

OVERTIME WORK AND FEES.

In exercise of the powers vested in the Comptroller by section 6 (4) of the Cap. 292. Customs Law, I hereby prescribe that from and after the 3rd January, 1954, overtime at the rates prescribed in the Schedule hereto shall be charged for the services of Customs Officers where permitted to carry out overtime outside the hours and days prescribed in clauses 2 and 3 of the Customs Houses (Days and Hours of Business) Order, 1953.

2. Overtime charges shall be calculated in full for each vessel or operation requiring the attendance of Customs Officers without reference to the number of vessels or operations being worked in any period.
