CLOSE SEASON (PERMITTED AREAS) ORDER.

1. This Order may be cited as the Close Season (Permitted Areas) Order.
2. Every holder of a Game Licence issued under the provisions of the Game and Wild Birds Protection Law, and subsisting for the time being, is hereby authorized—

- (a) to shoot, kill, take or pursue within any of the areas specified in the Appendix hereto any wild bird during the following part of the Close Season, that is to say, between the 21st day of January and the 31st day of March in every year, both days inclusive; and
- (b) to sell any wild bird so shot, killed or taken.

APPENDIX.

Nicosia District.

- (1) AREA—contained within the following boundary line :—

From the south-west corner of the Karavostasi Jetty, plan No. 19/58, the line goes north-east along the north side of the main road "Polis-Morphou" to the bridge on the "Komitis Potamos" at the north-east corner of plot No. 31, plan No. 19/40, locality "Yephiri-tou-Komiti"; thence north-east along this road and the road west of Morphou village to the junction of roads at the south-east corner of plot No. 213, plan No. 19/32, locality "Teratses"; thence north-east in a straight line crossing "Serachis Potamos" to the south-east corner of plot No. 100, plan No. 19/32, locality "Mandres Tsifikiou"; thence north-west along the right bank of "Serachis Potamos" as far as the road to Ayia Irini village at the south-west corner of plot No. 778, plan No. 19/24, locality "Dromos-Perivolion"; thence north-west along this road crossing "Ovgos Potamos" to the point where the footpath to "Aloupos" locality branches off at the south end of plot No. 235, plan No. 19/23, locality "Kasouris"; thence north-west along this footpath to its end on the rocky ridge at the north-west corner of plot No. 17, plan No. 19/6, locality "Petro-Mandres"; thence south-west in a straight line through the north-west corner of plot No. 71, plan No. 19/6, locality "Kato Livadhia" to the sea; thence south-west along the seashore to the starting point.

- (2) AREA—contained within the following boundary line :—

The boundary commences at the bridge about a quarter of a mile north-west of the village of Orta Keuy on the main Nicosia-Kyrenia road over the stream "Media Argaki" and goes eastwards down this stream to its junction with the river "Pedieos"; thence down this river to the bridge on the main Kythrea-Nicosia road; thence south-westwards along this main road to the Famagusta Gate of Nicosia; thence south-eastwards along the old Nicosia-Larnaca road for a distance of about a quarter of a mile to its junction with the road from the Greek cemetery; thence south-westwards along the latter road and continuing past the Greek cemetery to the bridge over the river "Pedieos" at Strovolos; thence south-westwards through the village to the road to Makedonitissa Monastery; and along this road to the said monastery; thence westwards along a road joining the main Nicosia-Troodos road between the fourth and fifth mile posts; thence eastwards along this main road to the track leading to the locality "Katsingaris," near the third mile

post ; thence northwards along this track to the main Nicosia-Myrtou road ; thence westwards along this road crossing the railway and along the track to Kolokosh Chiftlik ; thence northwards along a track to the bridge over the stream " Shemmos Potamos " on the road to the village of Skilloura ; thence down this stream and along " Media Argaki " to the starting point.

Limassol District.

AREA—The Akrotiri peninsula and Salt Lake, comprising the area south of the Limassol, Zakaki and Kolossi Road.

Famagusta District.

AREA—contained within the following boundary line :—

From Famagusta Harbour the line goes along the main road to the English cemetery ; thence along the village track through Kato Varosha, Avgorou, Athna, Makrasyka to Kouklia ; thence along the main road to Kondea ; thence along the Kondea-Lefkoniko road to Lefkoniko ; thence along the Lefkoniko-Trikomo road to the 30th mile post ; thence along the road to the wire fence of Syngrasi reservoir ; thence along the wire fence following the west, north and east boundaries of the Syngrasi reservoir to the main road near the bank of the reservoir ; thence along the road to the sea at Boghaz ; thence along the seashore to Famagusta Harbour.

Larnaca District.

(1) AREA—contained within the following boundary line :—

From Avlakia the line goes along the Aqueduct for the Larnaca Water Supply to St. George's Macri ; thence in a direct line to Pasha Chiftlik ; thence along the road to Dromolaxia, Meneou and Pervolia to the sea ; thence along the seashore to Cable House ; and thence by the Kalifakia road to Avlakia.

(2) AREA—contained within the following boundary line :—

From Larnaca the line goes along the Larnaca-Famagusta road to the point where it meets the Voroklini road ; thence it goes along the east side of the Voroklini Lake ; thence along the north side of the Livadhia Marsh to Larnaca ; and thence along the eastern boundary of Larnaca to the Larnaca-Famagusta road.

Paphos District.

AREA—contained within the following boundary line :—

From the mouth of the Ezuza river the line goes along the Ezuza river up to Akhelia bridge on the main road ; thence along the main road from Akhelia bridge to the Police Station Ktima ; thence along Katsikantari street, Municipality street, Slaughter-house street ; thence along Vrexi road to the seashore ; thence along the seashore to the mouth of the Ezuza river.

2. The areas specified in the Appendix hereto shall be and are hereby declared to be Game Reserves. Appendix.

Area No. 1 (Nicosia District) :

All that area known as the Athalassa Government Stock Farm and Plantation, all of which said area is enclosed with a wire fence and is more particularly shown on the Government Survey Plans Nos. XXI/63, XXI/64, XXX/7, XXX/8, XXX/15 and XXX/16.

Area No. 2 (Paphos District) :

All that area bounded on the north by the main road from Paphos to Limassol, on the east by the river " Khapotami," on the south by the sea and on the west by the river " Ezeuza", all of which said area is more particularly shown on the Government Survey Plans Nos. LI/28, LI/29, LI/30, LI/36, LI/37, LI/38, LI/39, LI/45, LI/46, LI/47, LI/48, LI/54, LI/55, LI/56, LI/64, LII/49 and LII/57.

Area No. 3 (partly in the Nicosia District and partly in the Paphos and Limassol Districts) :

All that area known as the Paphos State Forest, which said area is more particularly shown on the Government Survey Plans (to a scale of 1/5000) Nos. This area includes the villages of Kambos, Chakistra, Milikouri, Vroisha, in the District of Nicosia, Livadhi, Ayios Merkourios, in the District of Paphos, and the Monastery of Kykko and all concessions within the Paphos State Forest as recorded in the books of the Land Registry Office on the 3rd November, 1938, except such part thereof as relates to the private lands of the villages of Kambos, Chakistra and Milikouri and the Monastery of Kykko.

Area No. 4 (Limassol District) :

All that area bounded on the north by the main road from Paphos to Limassol, on the east by the river "Paramali", on the south by the sea and on the west by the river "Evdhimou", all of which said area is more particularly shown on the Government Survey Plans Nos. LII/63, LII/64, LIII/57, LVII/7, LVII/8, LVII/15, LVII/16 and LVIII/1.

Area No. 4A (Limassol District) :

All that part of the Limassol Main State Forest lying to the east of the main Parekklisha-Kellaki road, the boundary of which commences at the crossing of the Forest Delimitation line with the Parekklisha-Kellaki Road, follows that road northwards until it again crosses the Forest Delimitation line near cairn No. 380, then follows the Forest Delimitation line eastwards past cairns Nos. 380 to 403, then southwards past cairns Nos. 404 and 405, then westwards past cairns Nos. 406 to 411 and the Épilas point; then follows the Forest Delimitation line westwards past cairns Nos. 1 to 16 and to the point of commencement, all of which said area is more particularly shown on the Government Survey Plans Nos. LIV.7, XLVIII.63, XLVIII.64, LIV.8, LVI, LV.9, LIV.16.

Area No. 5 (Famagusta District) :

All that area bounded on the north by the road from the village of Ayios Andronikos to the Hamlet of Elisis, on the east by the road from the Hamlet of Elisis to the road leading from the village of Korovia to the village of Leonarisso via the village of Vathylakkas, and on the west by the road from the village of Leonarisso to the village of Ayios Andronikos, all of which said area is more particularly shown on the Government Survey Plans Nos. III/52, III/53, III/54, III/55, III/56, III/60, III/61, III/62, III/63, VIII/3, VIII/4 and VIII/5.
