CAP. 175.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Palodhia in the District of Limassol on the 26th October, 1953, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Palodhia ;

And whereas the Mukhtar of the said village of Palodhia has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Limassol, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Palodhia.

SCHEDULE.

The area lying within the following boundary that is to say:—

The boundary commences at the most northern point of plot No. 353 of the Government Survey Plan No. LIV.17, locality "Pygadhia", which point is on the boundary between the villages of Palodhia and Spitali and proceeds eastwards along the said boundary to the most western point of plot No. 178 of the said plan, which point is on the boundary between the villages of Palodhia and Phasoula; thence southwards, westwards and south-eastwards along the said boundary to the most northern point of plot No. 290 of the Government Survey Plan No. LIV.25, locality "Kommoritсос", which point is on the boundary between the villages of Palodhia and Ayia Phyla; thence westwards along the said boundary to the south-western corner of plot No. 70 of the said plan, locality "Lazaries"; thence north-westwards along the boundaries of and including the last mentioned plot, plots Nos. 69, 68, 67, 45, 46, 47, 48, 50, 49, 59 and 58 of the said plan, plots Nos. 204, 202, 201, 198 and 197 of the Government Survey Plan No. LIII.32, locality "Kapsales", to the north-western corner of the last mentioned plot which corner is on the left bank of the stream "Arghaki Vartalidon"; thence eastwards along the said bank of the said stream to its junction with another stream, "Arghaki tou Marathou"; thence northwards along the left bank of the last mentioned stream to its junction with a track leading from the village of Palodhia to the Church of Ayia Ereni; thence eastwards along the said track to its junction with the stream, "Arghaki tou Latsiou"; thence southwards and south-westwards along the right bank of the said stream to its junction with the stream "Arghaki Vartalidon"; thence eastwards along the left bank of the last mentioned stream to the north-western corner of plot No. 200 of the said plan; thence eastwards and southwards along the boundaries of and including the last mentioned plot of the said plan, plots Nos. 36, 40, 41, 42, 43, 55, 54 and 45 of the Government Survey Plan No. LIV.25, to the north-eastern corner of the last mentioned plot, locality "Anephin", which corner is on the Limassol-Agros road; thence northwards along the said road to the north-western corner of plot No. 88 of the said plan, locality "Kambos"; thence eastwards and northwards along the boundaries of and including the last mentioned plot, plots Nos. 92, 87, 85, 117, 116, 125 and 127 of the said plan, plots Nos. 278, 274, 273, 270, 281, 344, 346 and 359 to the most western point of the last mentioned plot of the Government Survey Plan No. LIV.17, locality "Yirous", which point is on a footpath; thence north-eastwards along the said footpath to the point of commencement. All which said boundary is shown edged red on the Government Survey Plan Serial No. 1597 and includes an area of 825 donums or thereabouts.
