No. 120. THE AGRICULTURAL PRODUCE EXPORT REGULATIONS, 1953.

Notice under Regulation 14 (b).

In exercise of the powers vested in me by regulation 14 (b) of the Agricultural Produce Export Regulations, 1953, and further to Notification No. 289 of 10th June, 1953, I, the Acting Director of Agriculture, do hereby order that, until further notification potatoes intended for export graded as "Selected" or "New potatoes" and separated into size "medium" shall be classified as "Medium No. 1" and "Medium No. 2" as described below. Their containers shall be marked accordingly in letters 1" in height.

"Medium No. 1" size potatoes are those which pass through a sieve with a mesh of  $2\frac{1}{4}$  inches square but which do not pass through a sieve with a

mesh of  $1\frac{3}{4}$  inches square.

"Medium No. 2" size potatoes are those which pass through a sieve with a mesh of  $2\frac{1}{2}$  inches square but which do not pass through a sieve with a mesh of 2 inches square.
