No. 14. ✓ THE PUBLIC HEALTH (VILLAGES) LAW.

ORDER IN COUNCIL No. 2661

MADE UNDER SECTION 10.

*Authority to the Village Health Commission of Kiti (Larnaca District)
to contract a loan.*

In exercise of the powers vested in me by section 10 of the Public Health (Villages) Law, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. The Village Health Commission of Kiti (Larnaca District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of two hundred and sixty pounds (£260) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

(a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in five equal annual instalments (comprising sinking fund and interest);

(b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate ;

(c) the sum borrowed shall be utilized by the Village Health Commission for the purpose of erecting a slaughter-house.

2. For the purposes of securing the repayment of the sum due under the loan the Village Health Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the fees, charges and rates now payable or hereafter to become payable to the Village Health Commission under the provisions of the Public Health (Villages) Law.

THE TURKISH RELIGIOUS HEAD (MUFTI) LAWS, 1953.

APPROVAL BY THE GOVERNOR UNDER SECTION 5.

Whereas the Presiding Officer has notified to me, under section 5 of the Turkish Religious Head (Mufti) Laws, 1953, the name of Mehmed Dana Effendi, as having been duly elected as Mufti, under the provisions of the aforesaid Laws at an election held on the 30th December, 1953, for my approval ;

And whereas I am satisfied that the person elected possesses the qualifications required under sub-section (1) of section 4 of the aforesaid Laws, inasmuch as it was so found by a Committee of three senior Turkish Judges of moslem faith constituted under sub-paragraph (2) of paragraph 9 of the Schedule to the aforesaid Laws :

Now, therefore, in exercise of the powers vested in me by section 5 of the aforesaid Laws, I, the Governor, do hereby signify my approval of the election of Mehmed Dana Effendi as Mufti under the provisions of the aforesaid Laws.

THE BOMBARDMENT RANGE AREAS LAW.

Whereas in exercise of the powers vested in me by section 2 of the Bombardment Range Areas Law, I, the Governor, by Notifications Nos. 104 and 105 dated the 29th February, 1952, and published in Supplement No. 3 to the *Gazette* of the 5th March, 1952, had declared certain areas therein enumerated to be Bombardment Range Areas for the purposes of the aforesaid Law for a period of twelve months from the date of the aforesaid notifications, which period was later extended till the 28th day of February, 1954, by Notification No. 21 dated the 13th January, 1953, and published in Supplement No. 3 to the *Gazette* of the 21st January, 1953 ;
