RULES MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LEFKONIKO.

In exercise of the powers vested in them by section 89 of the Municipal Corporations Law, the Council of the municipal corporation of Lefkoniko hereby make the following rules :—

I. These rules may be cited as the Lefkoniko (Financial) Rules, 1954.

2. In these rules—

"Mayor" means the mayor of the municipal corporation of Lefkoniko;

niko; "municipal corporation" means the municipal corporation of Lefkoniko;

"town clerk and treasurer" means the town clerk and treasurer of the municipal corporation of Lefkoniko.

3.—(1) All moneys of the municipal corporation in excess of \pounds 150 shall be paid into the account of the municipal corporation at the Co-operative Credit Society of Lefkoniko.

(2) All documents necessary for the lodging and withdrawal of moneys in or from such account shall be signed by the mayor and the town clerk and treasurer.
