REGULATIONS MADE UNDER SECTION 19.

Cap. 151. In exercise of the powers vested in me by section 19 of the Sale of Food and Drugs Law, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations :—

1. These regulations may be cited as the Dairies and Cowsheds (Amendment) Regulations, 1954, and shall be read as one with the Dairies and Cowsheds Regulations, 1938 (hereinafter referred to as "the principal Regulations") and these regulations and the principal Regulations may together be cited as the Dairies and Cowsheds Regulations, 1938 and 1954.

2. Regulation 3 of the principal Regulations is hereby amended by the addition thereto of the following sub-paragraphs.

"(4) Any registered cowkeeper or dairyman who ceases to own or carry on the trade of a cowkeeper or dairyman shall, within 28 days from ceasing so to do, notify the Dairy Registration Authority of such fact by returning the Registration certificate :

Provided that where any such person fails to notify the Dairy Registration Authority in accordance with these regulations, the registration of such person and the premises shall be deemed to have been cancelled at the end of the above-referred period.

(5) The Dairy Registration Authority may cancel any registration certificate under these regulations on the ground that the holder of such registration certificate has contravened the Sale of Food and Drugs Law or any regulations made thereunder."

No. 267. THE DANGEROUS DRUGS LAW.
CAP. 73 AND LAW 39 OF 1953.

ORDER IN COUNCIL No. 2679

MADE UNDER SECTION 12. (2).

Whereas it appears to His Excellency the Governor in Council that the drugs specified in the Schedule to this Order are productive, if improperly used, or are capable of being converted into a substance, which is, or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine.

Now, therefore, in exercise of the powers vested in him by section 12 (2) of the Dangerous Drugs Law, His Excellency the Governor with the advice of the Executive Council, does hereby order and declare as follows :—

1. Part III of the Dangerous Drugs Law shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part III applies to the drugs mentioned in sub-section (1) of section 12 of the Dangerous Drugs Law.

2. This Order is in addition to and not in derogation of any other existing Order applying Part III of the Dangerous Drugs Law to any other drugs.

SCHEDULE.

The salts of N-allylnormorphine and any preparation, admixture, extract or other substance containing any proportion of N-allylnormorphine.

Dhekelia	Any Customs store, Customs warehouse, wharf or other place provided or approved by Government for the landing or shipping of goods, which are subject to Customs control, and the territorial waters of Cyprus contained within Longitude 33° 42' 30" East and Longitude 33° 45' 50" East.
