**No. 298.** **THE MUNICIPAL CORPORATIONS LAW.**  
**CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951 AND 20 OF 1953.**

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF  
 LARNACA.

In exercise of the powers vested in them by the Municipal Corporations Law and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :—

1. These bye-laws may be cited as the Larnaca Municipal (Amendment) Bye-laws, 1954, and shall be read as one with the Larnaca Municipal Bye-laws, 1949 and 1953 (hereinafter referred to as "the principal Bye-laws") and the principal bye-laws and these bye-laws may together be cited as the Larnaca Municipal Bye-laws, 1949 to 1954.

2. Bye-law 153 of the principal Bye-laws is hereby amended as follows :—

(a) by the deletion of the semi-colon immediately after the word "competition" in paragraph (a) and the addition thereto of the words "the takings of which either wholly or in part are devoted to philanthropic, educational, or charitable purposes";

(b) by the deletion of paragraphs (c) and (d) and the substitution therefor of the following new paragraph (c) :—

"(c) to any public entertainment the takings of which either wholly or in part are devoted to philanthropic, educational, or charitable purposes".

The above bye-laws have been approved by His Excellency the Governor.
