SUBSIDIARY LEGISLATION.

No. 306. THE VILLAGE AUTHORITIES LAW. CAP. 256 AND LAW 17 OF 1951.

PROCLAMATION UNDER SECTION 18 (a).

Governor.

Whereas there now exists within the area of the village of Prastio in the District of Nicosia a settlement known as New Livadhi;

And whereas it is found expedient that the said settlement should be a quarter of the village of Prastio:

Now, therefore, in exercise of the powers vested in me by section 18 (a) of the Village Authorities Law, and of every other power and authority enabling me in that behalf, I, the Governor, do hereby order and proclaim that from and after the 1st day of June, 1954—

- (a) the settlement known as "New Livadhi" in the village of Prastio as more particularly described in Part I of the Schedule hereto shall, for all administrative purposes, form a quarter of the village of Prastio in the District of Nicosia, under the style of "New Livadhi quarter" of the said village;
- (b) the remaining area of the village of Prastio as more particularly described in Part II of the said Schedule shall, for all administrative purposes, form another quarter of the said village, under the style of "Ayios Yeorghios quarter" of the said village.

SCHEDULE.

PART I.

Boundary of New Livadhi Quarter, Prastio Village. Area "A"

The boundary commences at the north-western corner of plot No. 142 of Block "E", Prastio village, locality "Aloupotrypes" and proceeds eastwards and northwards along the boundaries of and including the last mentioned plot, plot Nos. 214, 215 and 23 of the said block, to the north-western corner of the last mentioned plot, which corner is on the boundary between the Villages of Prastio and Nikitas; thence southwards, north-westwards and south-eastwards along the said village boundary to the most southern point of plot No. 20 of Block "D", Prastio village, locality "Kafkaroudhin", which point is on a track leading from the village of Nikitas to Baraji Monastery; thence westwards along the northern side of the said track to the southeastern corner of plot No. 10 of the said block, which corner is at a junction of tracks; thence southwards along another track to the most southern point of plot No. 65 of the said block, which point is on the Polis-Morphou main road; thence westwards along the said main road to the most southern point of plot No. 35 of Block "C", Prastio village, locality "Loukki"; thence northwards and south-eastwards along the boundaries of and including the last mentioned plot and plot No. 29 of the said block, to the most southern point of plot No. 64 of Block "D", Prastio village, which point is on a track; thence northwards along the western side of the said track to the most southern corner of plot No. 46 of the said block, locality "Variyi"; thence north-westwards, westwards and northwards along the boundaries of and including the last mentioned plot, plot No. 5 of the said block, plot Nos. 143 and 142 of Block "E", Prastio village, to the point of commencement.

Area "B".

The boundary commences at the most western point of plot No. 98 of Block "C", Prastio village, locality "Phiniki", which point is on the Polis-Morphou main road and proceeds north-eastwards along the south-eastern side of the said main road to the most northern point of plot No. 69 of the said block; thence southwards, eastwards and southwards along the boundaries of and including the last mentioned plot, Nos. 94, 100, 102, 191, 199, 200, 201, 202, 203, 204, 205, 206, 207, 208, 209 and 217 of the said block, to the south-eastern corner of the last mentioned plot which corner is at a junction of tracks; thence eastwards along the northern side of a track to a point on the northern side of the said track opposite the north-eastern corner of plot No. 363 of the said block; thence southwards and south-westwards along the boundaries of and including the last mentioned plot, plot Nos. 362, 361, 360, 352, 351, 350, 349, 348, 347, 111, 301 and 113 of the said block, to the most southern point of the last mentioned plot, locality "Stavros", which point is on the right bank of a stream; thence north-westwards along the said bank to the point of commencement.

The boundaries of the said areas "A" and "B" are delineated in red on the Government Survey Plan Serial No. 1571.

PART II.

Boundary of Ayios Yeorghios Quarter, Prastio Village.

The boundary commences at the north-western corner of plot No. 1 of Block "E", Prastio village, locality "Livadhia", which corner is on the sea-shore and on the boundary between the villages of Prastio and Syriano-khori and proceeds eastwards along the said village boundary to the south-western corner of plot No. 161 of Block "D", Nikitas village, which corner is on the boundary between the villages of Prastio and Nikitas; thence south-eastwards along the said village boundary to the south-eastern corner of

plot No. 22 of Block "E", Prastio village; thence westwards and southwards along the boundaries of and including the last mentioned plot, plots Nos. 197, 204, 33, 32, 37, 221, 86, 87, 91, 128, 129, 130, 131, 224, 141 and 140 of the said block, locality "Variyi", plots Nos. 19 and 21 of Block "C", Prastio village, plots Nos. 4, 53, 47, 48, 50, 57, 58, 62, 160 and 64 of Block "D", Prastio village, to the south-eastern corner of the last mentioned plot, locality "Loukki", which corner is on a track; thence westwards along the said track to the north-eastern corner of plot No. 26 of Block."C", Prastio village; thence southwards along the boundaries of and including the last mentioned plot, plots Nos. 365, 28, 279 and 36 of the said block, to the northwestern corner of plot No. 69 of the said block, which corner is on the Polis-Morphou main road; thence westwards along the south-eastern side of the said road to the western corner of plot No. 136 of the said block, which corner is on the right bank of a stream; thence south-eastwards along the said bank to the most southern point of plot No. 113 of the said block, locality "Stavros"; thence north-eastwards and northwards along the boundaries of and excluding the last mentioned plot, plots Nos. 301, 111, 347, 348, 349, 350, 351, 352, 360, 361, 362 and 363 of the said block to a point on the northern side of a track opposite the north-eastern corner of the last mentioned plot; thence westwards along the northern side of the said track to the south-western corner of plot No. 104 of the said block, which corner is on a junction of tracks; thence north-eastwards along the northwestern side of a track to the south-eastern corner of plot No. 92 of the said block; thence westwards and northwards along the boundaries of and including the last mentioned plot, plots Nos. 93 and 367 of the said block, locality "Kamares", to the north-western corner of the last mentioned plot, which corner is on the Polis-Morphou main road; thence eastwards along the northern side of the said road to its junction with a track leading from Prastio village to Baraji Monastery; thence northwards along the western side of the said track to its junction with another track leading from Baraji Monastery to the village of Nikitas; thence south-eastwards along the northern side of the said track to the most eastern point of plot No. 21 of Block "D", Prastio village, locality "Kaphkaroudhin", which point is on the boundary between the villages of Prastio and Nikitas; thence southeastwards and southwards along the said village boundary to the most eastern point of plot No. 281 of Block "B", Prastio village, locality "Ambelia", which point is on the boundary between the villages of Prastio and Kato Zodhia; thence south-westwards along the said village boundary to the most northern point of plot No. 15 of Block "K", Kato Zodhia village, locality "Lithorotsos", which point is on the boundary between the villages of Prastio and Elea; thence north-westwards and south-westwards along the said village boundary to the north-eastern corner of plot No. 90 of Block "G", Elea village, locality "Karteri" which corner is on the boundary between the villages of Prastio and Ghaziveran; thence north-westwards along the said village boundary to the north-western corner of plot No. 276 of Block "B" Ghaziveran village, locality "Bozavas", which corner is on the seashore; thence north-eastwards along the sea-shore to the point of commencement, all which said boundary is shown delineated in red on the Government Survey Plan, Serial No. 1609.
