NOTICE UNDER SECTION 12.

25 of 1952. Whereas the Cyprus Cement Company Limited, a company registered in Cyprus and having its registered office at 22A T. P. O'Connor Street, in Limassol (hereinafter referred to as "the Licensees") are the holders of a licence dated the 17th August, 1953, granted under section 3 of the Cement Industry (Encouragement and Control) Law, 1952 (hereinafter referred to as "the Law");

And whereas a notice of the grant of the said licence was published under section 4 of the Law in Supplement No. 3 to the *Gazette* of the 3rd September, 1953;

And whereas, after the publication of the aforesaid notice, the Licensees require the lands, the particulars of which are set out in the Schedule hereto (hereinafter referred to as "the lands") to be acquired compulsorily for the purposes specified in paragraphs (b) and (e) of sub-section (1) of section 3 of the Law in respect of which the said licence was granted;

And whereas the Licensees did make application for the said acquisition to the Governor, accompanied by plans showing the particulars of the lands to be acquired, and by a statement giving the particular reasons for the proposed compulsory acquisition;

And whereas the Governor was satisfied that prima facie the acquisition may proceed, and requested the Licensees to deposit the plans and particulars with the Commissioner, Limassol;

And whereas the Licensees, after depositing the plans and particulars with the Commissioner, Limassol, on the 21st December, 1953, did cause notices to be served on all the persons interested in the lands, under the provisions of sub-section (1) of section 11 of the Law;

And whereas after the expiration of fifteen days from the service of the said notices, the Commissioner, Limassol, has forwarded to the Governor, under sub-section (2) of section 11 of the Law, the plans and particulars, together with the objections made:

Now, therefore, I, the Governor, in exercise of the powers vested in me by section 12 of the Law, do hereby approve the plans and particulars submitted and consider it expedient, having regard to all the circumstances of the case, that the lands shall be acquired, and do hereby sanction the acquisition of the lands.

No. 308. THE SUMMER AFTERNOON RECESS LAW.

CAP. 168 AND LAW 36 OF 1953.

ORDER IN COUNCIL No. 2686

MADE UNDER SECTION 3 (1).

In exercise of the powers vested in him under sub-section (1) of section 3 of the Summer Afternoon Recess Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

p. 328

1. This Order may be cited as the Summer Afternoon Recess Order, 1954.

2. Between the sixteenth day of May and the thirteenth day of September every year, both days inclusive, all places of business within the municipal limits of the towns of Nicosia, Limassol, Larnaca, Famagusta (including Varosha), Paphos and Kyrenia, and of the villages of Lefka, Lefkara, Lefkoniko, Morphou, Kythrea and Polis, and in Ayios Dhometios, Beuyuk Kaimakli, Engomi, Eylenja (Aglanja), Omorphita, Pallouriotissa, Strovolos and Trakhonas shall be closed and kept closed every day of the week for the interval between the hours shown below in respect of the places of business specified opposite such hours :—

Nicosia

(a) factories and workshops 1 p.m. to 3 p.m. ;

(b) other places of business 1 p.m. to 4 p.m. ;

Provided that the following places of business shall be exempted from the operation of this Order :—

(a) aerodromes ;

(b) bakehouses ;

(c) clubs ;

(d) chemists and druggists shops or stores ;

(e) electric power stations ;

(f) hotels, inns, khans, restaurants, cafés, bars ;

(g) ice factories ;

(h) offices of agencies for the hire of motor cars ;

(i) offices of shipping and travelling agencies ;

(j) premises occupied by medical practitioners, dentists or advocates in connection with the exercise of their work or profession ;

(k) public baths ;

(l) petrol filling stations (retail distribution centres) ;

(m) telegraph and telephone offices ;

(n) undertakers premises.

3. The Summer Afternoon Recess Order, 1943, is hereby revoked.
