## ORDER MADE BY THE GOVERNOR UNDER SECTION 14.

In exercise of the powers vested in him under section 14 of the Trading with the Enemy Law (hereinafter referred to as "the Law") and of every other power thereunto enabling, His Excellency the Governor, has been pleased to order as follows :—

1. This Order may be cited as the Trading with the Enemy (Enemy Territory Cessation) (Netherlands) Order, 1954.
2. The Netherlands shall for the purposes of sections 6, 7, 8 and 10 of the Law and for the purposes of any Order made under the said section 10 cease to be treated as if they were enemy territory.
3. For the purpose of this Order "the Netherlands" means all the territory in Europe of the Kingdom of the Netherlands and Netherlands New Guinea.
4. This Order shall be deemed to have come into operation on the 11th December, 1953.
