

No. 359. THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175.

ORDER UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Akanthou in the District of Famagusta on the 31st January, 1954, under the provisions of the Tree Planting (Village Areas) Law, it was determined by the requisite majority of the owners present thereat that certain areas should be reserved as a Tree Planting Area of the said village of Akanthou ;

And whereas the Mukhtar of the said village of Akanthou has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law :

Now, therefore, I, the Commissioner of the District of Famagusta, having approved the said report, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the village of Akanthou.

SCHEDULE.

The area lying within the following boundary that is to say :—

The boundary commences at the north-western corner of plot No. 64 of the Government Survey Plan No. XIV.1.E, locality "Moulos", which corner is on the Kyrenia-Akanthou main road and proceeds north-eastwards and southwards along the said main road to the north-eastern corner of plot No. 177/2 of the Government Survey Plan No. XIV.3, locality "Yerokolymbos", which corner is on the left bank of the "Yerokolymbos" stream ; thence southwards along the said bank to the source of the said stream at the most southern point of plot No. 775 of the said plan, locality "Pomisharika" ; thence south-eastwards along the boundaries of and including plots Nos. 28, 62, 61, 100, 135 (part), 139 and 184 of the Government Survey Plan No. XIV.11, to the most southern point of the last mentioned plot ; thence due south to the boundary of the "Malounda" Main State Forest ; thence westwards along the said forest boundary and through the forest cairns Nos. 8 and 7 to the Forest Cairn No. 6, on the Government Survey Plan No. XIV.10, locality "Mallina", which cairn is on the boundary between the villages of Akanthou and Ayios Nikolaos ; thence westwards along the said village boundary to the Forest Cairn No. 35, on the Government Survey Plan No. XIV.10, which cairn is on the boundary of the "Mavron Oros" Main State Forest ; thence westwards along the said forest boundary to the most southern point of plot No. 115 of the Government Survey Plan No. XIV.9 which point is on the boundary of Famagusta and Kyrenia Districts ; thence north-westwards and northwards along the said district boundary to the north-western corner of plot No. 1, of the said plan, locality "Moulos" ; thence north-westwards along the boundaries of and including plots Nos. 99, 82 and 81, of the Government Survey Plan No. XIV.1, to the point of commencement, all which said boundary is shown edged red on the Government Survey Plan Serial No. 1614 and includes an area of 5,942 donums or thereabouts.
