No. 412. THE GAME AND WILD BIRDS PROTECTION LAW.
CAP. 98 AND LAWS 23 OF 1950 AND 3 OF 1953.

ORDER IN COUNCIL No. 2695
MADE UNDER SECTION 18.

In exercise of the powers vested in him by section 18 of the Game and Wild Birds Protection Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows:—

1. This Order may be cited as the Game Reserve Areas (Amendment) Order, 1954, and shall be read as one with the Game Reserve Areas Orders, 1938 to 1952 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Game Reserve Areas Orders, 1938 to 1954.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of Area No. 2 (Paphos District) and the substitution therefor of the following area:—

" AREA No. 2 (PAPHOS DISTRICT) :

All that area the boundary of which commences at the junction of the Paphos-Limassol main road with the road leading from the village of Mamonnia, locality "Vounaros" and proceeds north-eastwards along the said village road to its junction with a track, which junction is at the most western point of plot No. 274 of the Government Survey Plan No. LII.25, locality "Akoni"; thence south-eastwards along the said track to the right bank of the river Dhiarrizos; thence south-eastwards in a straight line across the said river, to the most northern point of plot No. 252 of the said plan, locality "Tsamadhi", which point is on a track; thence eastwards along the said track to its junction with the village road leading from the village of Souskiou to the village of Koukليا; thence westwards, southwards and south-westwards along the said village road through the village of Koukليا to its junction with the Paphos-Limassol main road, locality "Ayia Marina"; thence south-eastwards along the said main road to the bridge over the river Khapotami, locality "Pyrgos"; thence westwards along the right bank of the said river to the sea-shore; thence north-westwards along the said sea-shore to the left bank of the river Ezouza; thence north-eastwards along the said bank of the said river to the Akhelia bridge carrying the Paphos-Limassol main road over the said river; thence south-eastwards along the said main road to the point of commencement, all which said boundary is shown edged red on the Government Survey Plan No. 1615."
