No. 418. ✓ NOTIFICATION UNDER THE TREE PLANTING (VILLAGE  
AREAS) LAW.  
CAP. 175.

AKANTHOU (FAMAGUSTA) FUND.

In exercise of the powers vested in me by section 17 of the Tree Planting (Village Areas) Law, I hereby establish a fund for the village of Akanthou in the District of Famagusta (hereinafter called the "Fund") into which shall be paid all fines recovered under the said Law for offences committed within the Tree Planting Area of the village of Akanthou as described in the Order of the Commissioner of Famagusta published in Supplement No. 3 of the *Cyprus Gazette* No. 3761 of the 3rd June, 1954, under Notification 359.

The Fund shall be under the management and control of the Commissioner of Famagusta for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Akanthou.
