

THE LAND ACQUISITION (PAPHOS EARTHQUAKE) LAWS, 1953 AND 1954.

ORDER MADE UNDER SECTION 3 (1) (a).

Whereas under section 3 (1) (a) of the Land Acquisition (Paphos Earthquake) Laws, 1953 and 1954, the Commissioner has power to acquire, by order, any land which, in his opinion, is required for the purpose of resiting any village, or part thereof, in the Paphos District, which has been totally or partially destroyed by earthquake.

And whereas certain land is required for this purpose in consequence of the earthquake which occurred on the 10th September, 1953 :

Now, therefore, in exercise of the powers vested in me under section 3 (1) (a) of the Land Acquisition (Paphos Earthquake) Laws, 1953 and 1954, I, Robert Chattan Ross-Clunis, Commissioner of Paphos District, do hereby order that the areas of land, particulars and description of which are given on the Schedule hereto, be acquired for the above purpose.
