NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 109 in Supplement No. 3 to the *Gazette* of the 18th March, 1948, (as amended by Notification No. 192 published in Supplement No. 3 to the *Gazette* of the 27th May, 1948), the Governor declared the establishment of certain installations for use by Her Majesty's Air Force Authorities in or near the village of Kaimakli in the District of Nicosia to be an undertaking of public utility ;

And whereas the Commissioner, Nicosia, by notice published under Notification No. 294 in Supplement No. 3 to the *Gazette* of the 6th May, 1954, gave particulars of the properties (hereinafter referred to as "the properties") required in connection with the aforesaid undertaking ;

And whereas the Commissioner, Nicosia, forwarded to the Governor the required recommendations, plan and particulars, together with the objections made ;

And whereas, I, the Governor, have approved the plan and particulars submitted, and have considered it expedient, having regard to all the circumstances of the case, that the properties be acquired :

Now, therefore, in exercise of the powers vested in me by section 7 of the Land Acquisition Law, I, the Governor, do hereby sanction the acquisition under the provisions of the said Law, of the properties.

AMENDMENT OF NOTIFICATIONS UNDER SECTIONS 2, 3 AND 4.
