NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 28th August, 1954, and the 30th September, 1954, flocks within the area of Pendayia village, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.

THE LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTICE UNDER SECTION 19.

Whereas the Governor by notification No. 186 in Supplement No. 3 to the *Gazette* of the 3rd July, 1947, declared the construction of a power station, offices, workmen's quarters and any other erections or structures considered to be necessary in connection with a scheme for the generation and supply of electricity in Cyprus, to be an undertaking of public utility;

And whereas the Governor, by notification No. 326 in Supplement No. 3 to the *Gazette* of the 30th October, 1947, sanctioned the acquisition of, *inter alia*, the properties described in the schedule below for the said undertaking ;
