

No. 56. THE BOMBARDMENT RANGE AREAS LAW.
CAP. 222 AND LAW 23 OF 1951.

In exercise of the powers vested in me by section 2 of the Bombardment Range Areas Law, I, the Governor, do hereby declare the areas set out in the Schedule hereto to be Bombardment Range Areas for the purposes of the aforesaid Law for a period of one month commencing on the 1st day of February, 1954.

SCHEDULE.

The Akamas Bombardment Range Area.

All that area of the Akamas Forest which lies within the boundary which commences at a point on the sea-coast, which point is 1,200 feet or thereabouts, north-west of Ayios Epiphaniou and proceeds south-eastwards along the said sea-coast to a point 800 feet or thereabouts, north-west of the mouth of Argaki tis Mesoyiou; thence southwards for a distance of one mile 600 yards or thereabouts passing through localities "Plaki", "Kambos tou Ayiou Nikolaou", "Kato Vakhines" and "Kapsala tou Potrypitou" to the Triangulation Point No. 1073/4; thence south-eastwards for a distance of 4,130 feet or thereabouts, passing through localities "Kantara tis Koumarkas" and "Stavropiyi" to a point in locality "Mutti tis Kapsalas"; thence southwards for a distance of 4,850 feet or thereabouts, passing through localities "Kiladhia tis Kapsalomutis", "Muti tou Haji Sherifi", "Stiadhi tou Apparou" and "Muti tou Pastourma" to a point 1,300 feet or thereabouts, west of Triangulation Point "Mavri Shinia"; thence southwards for a distance of 3,700 feet or thereabouts, passing through localities "Kataklistres", "Mavri Shinia" and "Muti tou Gaidharou" to a point 1,500 feet or thereabouts, west of Triangulation Point No. 913/4; thence due west for a distance of two miles 263 yards or thereabouts, passing through localities "Petres pou Khaloun", "Kaphkalla tou Samakiou", "Kiladhi tou Dhimmatou" and "Dhamalospiliou", Triangulation Point No. 1088/4 to a point on the sea coast; thence northwards along the said sea-coast to the most southern point of the Akamas Bombardment Range Area, the boundaries of which were published under Notification No. 295 of Supplement No. 3 to the *Cyprus Gazette* of 1949; thence along the south-eastern and eastern boundaries of the said Bombardment Range Area to the point of commencement. The eastern and southern boundary of the said area is more particularly marked on the ground by Notice Boards sited every 1,800 feet and on the map 1 : 50,000 Cyprus, Sheet 1, Polis, by the points, the map references of which are : 085587, 085565, 093549, 092540, 094530 and 059530.
