THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 16th September and the 10th October, 1954, flocks within the area of Syrianokhori village, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.

THE LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTICE UNDER SECTION 6.

With reference to the Notification No. 108 published in Supplement No. 3 to the *Gazette* of the 18th March, 1948 (as amended by Notification No. 191 published in Supplement No. 3 to the *Gazette* of the 27th May, 1948, and Notification No. 499 published in Supplement No. 3 to the *Gazette* of the 12th August, 1954) notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein :—

All those areas of privately-owned land, situated in the village of Dherinia, in the District of Famagusta, at the localities Kourkounia and Kamini-tou-Yiallili, comprising 86 donums or thereabouts, including plots Nos. 329, 325, 328, 326, 327 and 342.1 of the Government Survey Plan No. XXXIII, 26, Plots Nos. 329, 330, 331, 332 and part of plots Nos. 318, 328, 327 and 333 of the Government Survey Plan No. XXXIII, 27, and plot No. 210 of the Government Survey Plan No. XXXIII, 35, more particularly defined as the areas coloured red on the Government Survey Plan marked R.A.F. INSTALLATIONS (EXTENSION), DHERINIA dated the 20th August, 1954, and signed by the Assistant Director of Hirings, Cyprus, M.E.L.F.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Governor is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office.
