Whereas by Notice published under No. 427 in Supplement No. 3 to the *Gazette* of the 3rd September, 1953, the Commissioner, Famagusta, has given notice that an area of privately-owned immovable property was required by the Board of the Improvement Area of Asha for the purpose of improving the domestic water supply;
