THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS) LAWS,  
1951 AND 1952.

ORDER IN COUNCIL No. 2714

MADE UNDER SECTION 3.

Whereas by an Order in Council made under section 3 of the Water Supply (Municipal and Other Areas) Law, 1951, and published under Notification No. 327 in Supplement No. 3 to the *Gazette* of the 27th June, 1951 (hereinafter referred to as "the principal Order"), the area of supply described in the Schedule thereto was declared as an area of supply and a Board was established for such area ;

And whereas the Governor in Council is satisfied that the provision of water supplies for the area of supply and the conservation of water resources for the purpose of such provision may be more effectively protected by the inclusion of the area described in the Schedule hereto within the area of supply :

Now, therefore, in exercise of the powers vested in him by section 3 of the Water Supply (Municipal and Other Areas) Laws, 1951 and 1952, and of every other power thereunto enabling, His Excellency the Governor, with the advice of the Executive Council, has been pleased to declare that the area described in the Schedule hereto shall be an area of supply for the purposes of the said Laws and form part of the area of supply declared by the principal Order and that that area and the present area shall be deemed to be one area of supply for the purposes of the said Laws.

SCHEDULE.

*Area of Supply.*

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 524 of Block D, Orta Keuy village and proceeds in an easterly direction along the boundaries of and including the said plot, plot No. 1500 of Block F, Orta Keuy village, plot No. 523 of Block D, Orta Keuy village, plot No. 1501 of Block F, Orta Keuy village, to the most eastern point of the last mentioned plot ; thence north-eastwards and south-eastwards along the boundaries of and including plots Nos. 21, 22, 23, 24, 25, 26 and 27 of the said Block, plots Nos. 109, 154, 155 and 156 of Block E, Orta Keuy

village, plot No. 1502 of Block F, Orta Keuy village, to the most eastern point of the last mentioned plot, which point is at a corner of the bridge carrying the Nicosia-Kyrenia road over the river Pedieos ; thence south-westwards along the left bank of the said river to the north-eastern corner of plot No. 1503 of Block F, Orta Keuy village ; thence in a westerly and northerly direction along the boundaries of and including the said plot, plot No. 1505, of the said Block to the point of commencement, all which boundary of the said area of supply is shown edged red on the Government Survey Plan Serial No. 1622.

THE ANTIQUITIES LAW.

CAP. 43.

REGULATIONS MADE UNDER SECTION 35 (d).

In exercise of the powers vested in him by section 35 (d) of the Antiquities Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations :—

1. These regulations may be cited as the Antiquities (Admission Fees to Museums and Ancient Monuments) (Amendment) Regulations, 1954, and shall be read as one with the Antiquities (Admission Fees to Museums and Ancient Monuments) Regulations, 1950 to 1953 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Antiquities (Admission Fees to Museums and Ancient Monuments) Regulations, 1950 to 1954.

2. The Schedule to the principal Regulations is hereby amended by the insertion therein, in its appropriate columns under the heading "Famagusta District" of the particulars set out in the columns of the Appendix hereto respectively.
