

No. 606. ✓ THE EXCHANGE CONTROL LAW, 1952.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 23, 24 AND 33.

In exercise of the powers vested in me by sections 23, 24 and 33 of the Exchange Control Law, 1952, I, the Financial Secretary, hereby order as follows :—

1. This Order may be cited as the Exchange Control (Import and Export) (Amendment) Order, 1954, and shall be read as one with the Exchange Control (Import and Export) Order, 1953 (hereinafter referred to as "the principal Order").

2. The principal Order is hereby amended by the insertion therein, immediately after sub-paragraph (a) of paragraph (1) of clause 4 thereof, of the following sub-paragraph :—

"(aa) by post addressed to a banker in the United Kingdom or the Channel Islands—

- (i) of any note of the Bank of England for £10 or more than £10 ;
- (ii) of any note of the Bank of England for £5 bearing a date prior to the second day of September, nineteen hundred and forty-four ;".

3. This Order shall be deemed to have been made and to have come into force on the 30th day of September, 1954.

EXPLANATORY NOTE.

*(This Note is not part of the Order, but is intended to indicate its general purport).*

This Order amends the Exchange Control (Import and Export) Order, 1953, by permitting the export of Bank of England notes for £10 and upwards and notes of £5 dated prior to the 2nd September, 1944, sent by post addressed to a banker in the United Kingdom or the Channel Islands.

THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.

NOTICE UNDER SECTION 27.
