**THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950 AND 1953.**

APPOINTMENT OF MEMBERS UNDER SECTION 7.

Whereas the area of Troodos, being an area deemed to have been declared under the provisions of section 3 (2) of the Summer Resorts (Development) Law, as a summer resort for the purposes of the aforesaid Law, is deemed, under the provisions of section 3 of the Villages (Administration and Improvement) Laws, 1950 and 1953, to have been declared to be an improvement area and is such an area for the purposes of the last mentioned Laws : Cap. 255.

And whereas it is necessary to appoint members of the Board of such improvement area :

Now, therefore, in exercise of the powers vested in the Governor by section 7 (1) of the Villages (Administration and Improvement) Laws, 1950 and 1953, I, the Governor's Deputy do hereby appoint the following persons to be members of the Improvement Board of Troodos to hold office for a period of four years from the 30th day of October, 1954, unless their appointment is previously terminated by the Governor—

- (a) The Conservator of Forests or his representative ;
- (b) The Director of Information Services or his representative ;
- (c) A representative of the Officer Commanding Cyprus District.

**THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS) LAWS,
1951 AND 1952.**

NOTIFICATION UNDER SECTION 18 (4). ✓

Whereas the Water Board of Famagusta (hereinafter referred to as "the Board") have, by a unanimous resolution, passed under section 18 (1) of the Water Supply (Municipal and Other Areas) Laws, 1951 and 1952, decided that certain immovable property specified therein should be acquired for the purpose of preventing the use of the two boreholes situated therein in the interests of the water supply of the town of Famagusta ;

And whereas the Commissioner of Famagusta, as Chairman of the Board, by notice published under Notification No. 443 in Supplement No. 3 to the *Gazette* of the 15th July, 1954, and posted at a conspicuous place within the area concerned on the 7th July, 1954, gave under section 18 (2) of the aforesaid Laws particulars of the immovable property required (hereinafter referred to as "the immovable property");

And whereas at the expiration of the period set out in the said notice the Chairman of the Board forwarded to the Governor all the documents required under section 18 (1) of the aforesaid Laws together with two objections made against the proposed acquisition;

And whereas I, the Governor's Deputy, have approved the plan submitted and have considered it expedient, having regard to all the circumstances of the case, that the Board should be permitted to acquire the immovable property:

Now, therefore, in exercise of the powers vested in the Governor by section 18 (4) of the Water Supply (Municipal and Other Areas) Laws, 1951 and 1952, I do hereby sanction the acquisition of the immovable property under the provisions of the aforesaid Laws.

THE AIR TRANSPORT (LICENSING OF AIR SERVICES)
REGULATIONS, 1948 TO 1953.
