THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)  
LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF AYIOS DHOMETIOS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Ayios Dhometios hereby make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Ayios Dhometios (Amendment) Bye-laws, 1954, and shall be read as one with the Villages (Administration and Improvement) Ayios Dhometios Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Ayios Dhometios Bye-laws, 1951 to 1954.

2. The principal Bye-laws are hereby amended by the insertion therein, immediately after bye-law 166, of the following bye-law :—

" 166A. Any person driving or having the charge or control of a motor car, or riding a bicycle, or driving, pushing or having the charge or control of an animal-drawn vehicle, in any street shall—

- (a) comply with all traffic signs erected, exhibited, placed or painted in or near any street by the Board ;
- (b) obey all notices or signs which may be erected, exhibited, placed or painted by the Board in or near any street or so as to be visible from any street, for the regulation of traffic ;
- (c) when entering into a main street, slow down or halt and give way to traffic in the main street."

The above bye-laws have been approved by the Colonial Secretary.

No. 642. THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

The following rules made by the Village Health Commission of Kazaphani, in the District of Kyrenia, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF KAZAPHANI UNDER SECTION 9.

In exercise of the powers vested in them by section 9 (1) (c) of the Public Health (Villages) Law, the Village Health Commission of Kazaphani hereby make the following rules :—

1. These rules may be cited as the Village Health (Kazaphani) (Amendment) Rules, 1954, and shall be read as one with the Village Health (Kazaphani) Rules, 1938 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Village Health (Kazaphani) Rules, 1938 and 1954.

2. Rule 86 of the principal Rules is hereby repealed and the following rule substituted therefor :—

" Rule 86. There shall be paid by every occupier in the village in every year a rate not exceeding £10 to be assessed by the Village Health Commission according to the means of each such occupier."
