RULES MADE BY THE VILLAGE HEALTH COMMISSION OF AYIOS EPIKITITOS  
UNDER SECTION 9.

In exercise of the powers vested in them by section 9 (1) (c) of the Public Health (Villages) Law, the Village Health Commission of Ayios Epiktitos hereby make the following rules :—

1. These rules may be cited as the Village Health (Ayios Epiktitos) (Amendment) Rules, 1954, and shall be read as one with the Village Health (Ayios Epiktitos) Rules, 1938 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Village Health (Ayios Epiktitos) Rules, 1938 and 1954.

2. Rule 86 of the principal Rules is hereby repealed and the following rule substituted therefor :—

"Rule 86. There shall be paid by every occupier in the village in every year a rate not exceeding £10 to be assessed by the Village Health Commission according to the means of each such occupier."
