# THE CEMENT INDUSTRY (ENCOURAGEMENT AND CONTROL) LAW, 1952.

### NOTICE UNDER SECTION 9 (2).

## R. P. Armitage,

Governor.

Whereas the Cyprus Cement Company Limited, a company registered in Cyprus and having its registered office at 22A T. P. O'Connor Street, in Limassol (hereinafter referred to as "the Licensees") are the holders of a licence dated the 17th August, 1953, granted under section 3 of the Cement Industry (Encouragement and Control) Law, 1952 (hereinafter referred to as "the Law");

And whereas a notice of the grant of the said licence to the Licensees was published under section 4 of the Law in Supplement No. 3 to the *Gazette* of the 3rd September, 1953;

And whereas the owners of the private lands, the particulars of which are set out in the Schedule hereto (hereinafter referred to as "the lands"), on which quarrying operations are to be carried out by the Licensees, refuse to sell the lands to the Licensees;

And whereas the Licensees have referred the matter to the Governor under sub-section (2) of section 9 of the Law;

And whereas I, the Governor, am satisfied that it is in the public interest that the quarrying operations proposed to be carried out on the lands by the Licensees should be undertaken and that failure to acquire the lands will seriously impede or prevent such operations :

Now, therefore, in exercise of the powers vested in me by sub-section (2) of section 9 of the Law, I, the Governor, do hereby sanction the acquisition of the lands under the provisions of the Law.
