

No. 670. ✓ THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 7, 25 AND 33.

In exercise of the powers vested in me by sections 7, 25 and 33 of the Exchange Control Laws, 1952 and 1954, I, the Financial Secretary, hereby order as follows :—

i. This Order may be cited as the Exchange Control (Payments) (Amendment No. 2) Order, 1954, and shall be read as one with the Exchange Control (Payments) Orders, 1954 (hereinafter referred to as “ the principal Order ”), and the principal Order and this Order may together be cited as the Exchange Control (Payments) (No. 2) Orders, 1954.

2. The principal Order is hereby amended—

(a) by the substitution for clause 4 thereof of the following clause :—

“ 4. The exemptions from the provisions of section 7 of the Law, granted by this Order shall not apply in relation to the transfer of the whole or any part of an amount standing to the credit of a No. 2 Account of a bank in Egypt, except in so far as the transfer may be from one such account to another such account.” ;

(b) by the deletion in paragraph (e) of clause 6 thereof of the words “ (other than Persia) ” ;

(c) by the deletion of item 14 in the Third Schedule thereto.

3. This Order shall be deemed to have been made and to have come into force on the 3rd day of November, 1954.

EXPLANATORY NOTE.

(*This Note is not part of the Order, but is intended to indicate its general purport.*)

This Order amends the Exchange Control (Payments) Orders, 1954, by including Persia in the Transferable Account territories.

The following rules made by the Village Health Commission of Bellapais, in the District of Kyrenia, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF BELLAPAIS UNDER SECTION 9.

In exercise of the powers vested in them by section 9 (1) (c) of the Public Health (Villages) Law, the Village Health Commission of Bellapais hereby make the following rules :—

1. These rules may be cited as the Village Health (Bellapais) (Amendment) Rules, 1954, and shall be read as one with the Village Health (Bellapais) Rules, 1938 (hereinafter referred to as “ the principal Rules ”) and the principal Rules and these rules may together be cited as the Village Health (Bellapais) Rules, 1938 and 1954.

2. Rule 86 of the principal Rules is hereby repealed and the following rule substituted therefor :—

“ Rule 86. There shall be paid by every occupier in the village in every year a rate not exceeding £10 to be assessed by the Village Health Commission according to the means of each such occupier.”
