No. 676. ✓ THE LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTICE UNDER SECTIONS 2, 3 AND 5.

R. P. ARMITAGE,

Governor.

Whereas it has been represented to me that it is desirable in the public interest to acquire certain lands situated at Peristerona in the District of Nicosia, for the purpose of constructing and protecting a bye-pass on the north of Peristerona :

Now, therefore, in exercise of the powers vested in me by sections 2, 3 and 5 of the Land Acquisition Law, I, the Governor, do hereby declare the acquisition of the said lands for the aforesaid purposes to be an undertaking of public utility and do hereby entrust the Director of Public Works with the supervision and effectuation of the said undertaking.

No. 677. ✓ THE MUNICIPAL CORPORATIONS LAW.

ORDER IN COUNCIL No. 2718

MADE UNDER SECTION 124 (1).

Authority to the Council of the Municipal Corporation of Athienou to contract a loan.

In exercise of the powers vested in him by section 124 (1) of the Municipal Corporations Law, His Excellency the Governor with the advice of the Executive Council, has been pleased to order as follows :—

1. The Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Athienou (hereinafter referred to as " the Municipal Corporation ") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as " the Lender ") the sum of one thousand and five

hundred pounds (£1,500) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Municipal Corporation to the Lender in ten equal annual instalments (comprising sinking fund and interest) the first instalment being payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding date of each year following until final repayment ;
- (b) the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual sum payable as aforesaid in the year to which such estimates relate ;
- (c) the sum borrowed shall be utilized by the Municipal Corporation for asphaltting the main streets within the municipal limits of Athienou and for the completion of the public market.

2. For the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
ACT, 1945.

ORDER MADE BY THE GOVERNOR.

In exercise of the powers vested in him by the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Colony by the Supplies and Services (Transitional Powers) (Colonies, etc.) Order in Council, 1946, which continues in force under the Supplies and Services (Continuance) Order, 1953, His Excellency the Governor has been pleased to order as follows:—

1. These Regulations may be cited as the Defence (Exportation of Goods) (Amendment) Regulations, 1954, and shall be read as one with Defence (Exportation of Goods) Regulations, 1943 to 1953 (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may together be cited as the Defence (Exportation of Goods) Regulations, 1943 to 1954.

2. Regulation 2 of the principal Regulations is hereby amended by the substitution of the words "Financial Secretary" for the words "Colonial Secretary", wherever the latter words occur.
